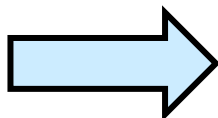

Retail Association Cooperative Agreement

- **AFDO**
 - **Successfully managed the Retail Association cooperative agreement for the last 3 years**
 - **Provided \$3M in funding and made over 680 awards**
 - **Provided a simple application and reporting process**
- **2016 New cooperative agreement awarded to AFDO**
 - **Five years**
 - **Over \$2M available to State, local, tribal and territorial retail programs**

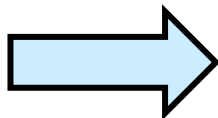

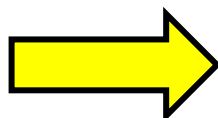

New Category- Travel & Training related to FPTF

- **Recommendation from FPTF Workshop held in February at the 2016 MFRP Alliance Meeting**
- **Funding will enable states to:**
 - **Increase attendance at State FPTF meetings and other sponsored events**
 - **Increase involvement of locals and tribes**
 - **Enhance collaboration between state task forces**
 - **Promote sharing of resources and best practices**

Retail Association Cooperative Agreement



- Can apply for up to one grant in each category; total of **4** per calendar year
- Can apply even if your program receives funds from other FDA sources (expected outcomes must be different)
- Simple application and reporting process
- Expect application portal to open Fall 2016
- Must be enrolled in order to apply
- Category 2 applications require current Self-Assessment

- 311 applications; 155 awards;
- total funds awarded \$450,000

Year
2

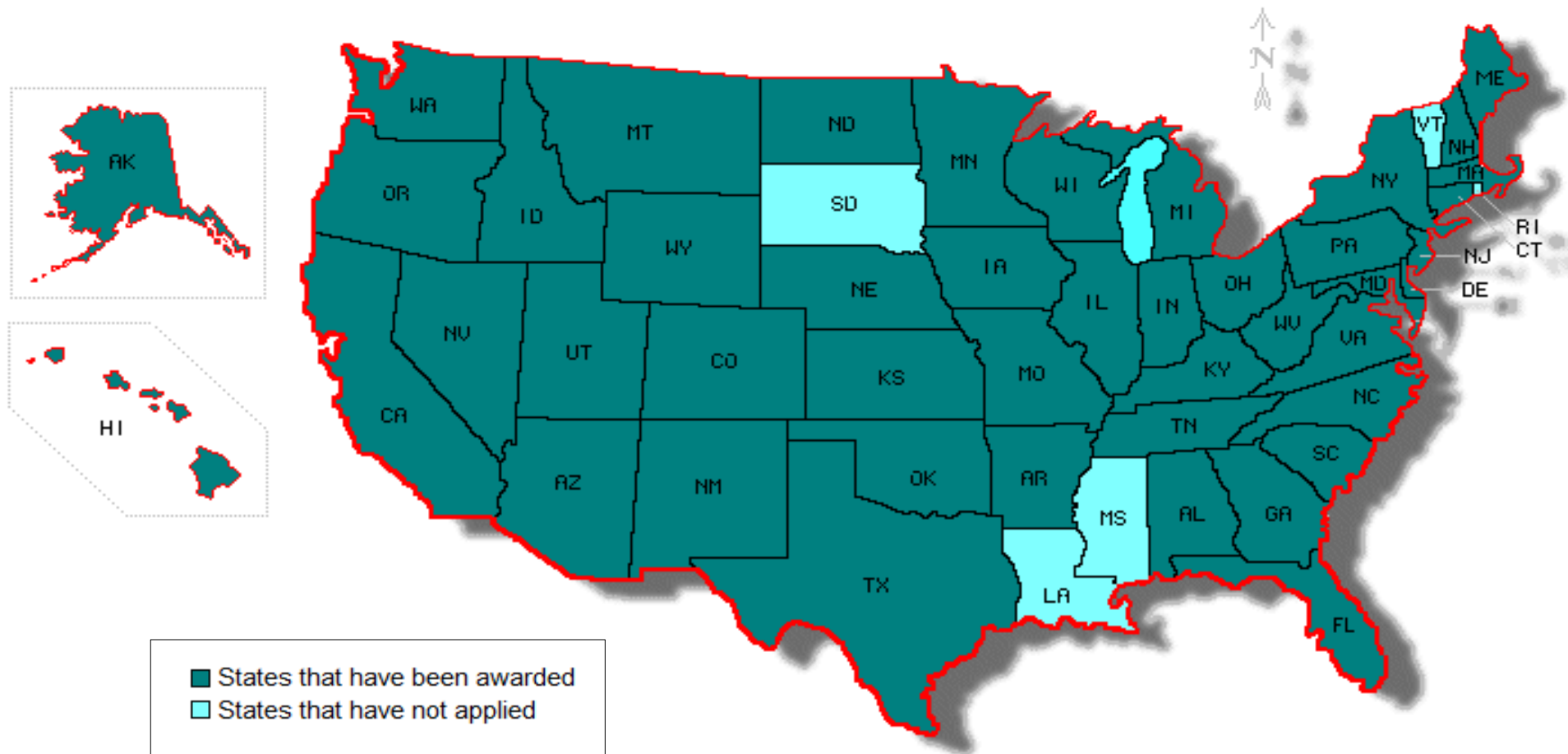
- 321 applications; 179 awards;
- Total funds awarded \$502,500

Year 3

- 355 applications; 350 awards;
- total funds awarded \$1,969,863

Outcomes of Moderate Projects

- **Conduct Risk Factor Studies**
- **Develop & implement electronic inspection system**
- **Electronic inspection & complaint forms**
- **Enhance existing software to improve data collection, tracking & reports**
- **Develop and implement a training tracking system**

AFDO Cooperative Agreement Awards Central Region

Year 3 - 102 awards

- **Category 1 Awards = 42**
 - Self Assessments: 17
 - Verification Audit of 1 Standard: 2
 - Verification Audit of 2 or more Standards: 7
 - Small Projects: 16
- **Category 2 – Moderate Project Awards = 24**
- **Category 3 – Training Awards = 36**

- **NACCHO**

- **Successfully managed the Mentorship Program for the last 5 years**

Mentorship Program

- **NEW cooperative agreement**
 - **Managed by NACCHO**
 - **Five years**
 - **Approximately \$240,000 in available funding**
- **Funds used to purchase field supplies for inspections (i.e. laptops), cover registration and costs to attend training and educational conferences, pay staff time, hire interns and consultants**
- **Expect next request for applications in the Fall 2016**

FoodSHIELD

PURPOSE:

- FoodSHIELD is a secure, web-based system offering a wide range of tools and resources to facilitate information sharing and communication between local, state and federal partners collaborate with other regulatory partners

Facilitates:

- Sharing ongoing event information such as recalls
- Hosting or participating in workgroups
- Hosting or participating in trainings or meetings
- Work planning

FoodSHIELD

- FoodSHIELD's mission is to provide an online environment for users to interact and function as a unified network
- A workgroup can be composed of government representatives from the federal, state, and local levels, as well as non-government officials, including industry representatives, who are invited to a workgroup by a government representative
- Enable members across different regulatory jurisdictions and agencies to coordinate and integrate their ideas and efforts

FoodSHIELD

FEATURES:

- Hold Web Meetings
- Document Library-Upload documents for collaboration and group editing
- Meeting Scheduler-Survey group for available meeting times
- Calendar-Online calendar for group appointments or tasks
- News Board-Post relevant information in a message board format to share with group
- News Feeds-Subscribe to relevant RSS feeds to aggregate and display external news
- Polls-Conduct internal poll of group members
